### **Financial Changes**

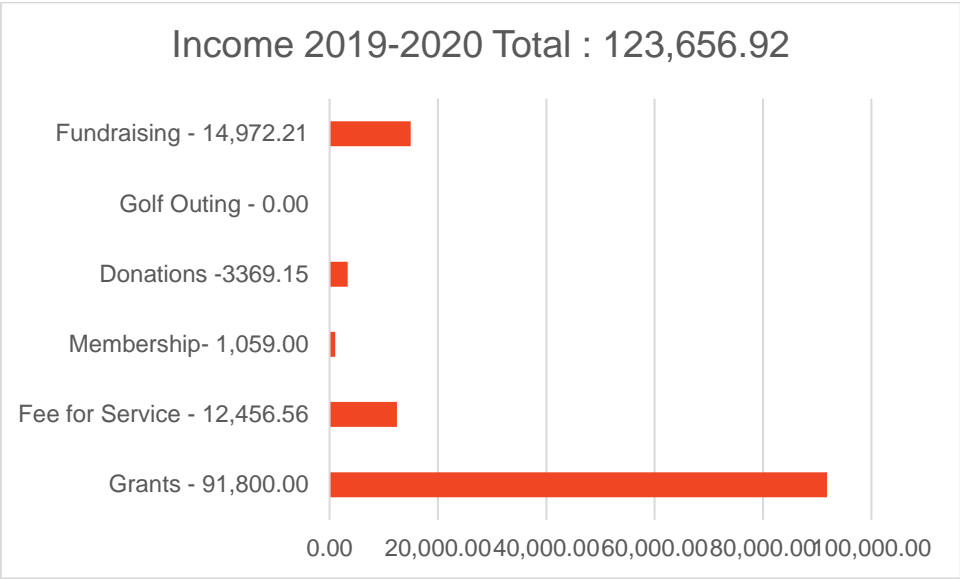

### **Looking Ahead**

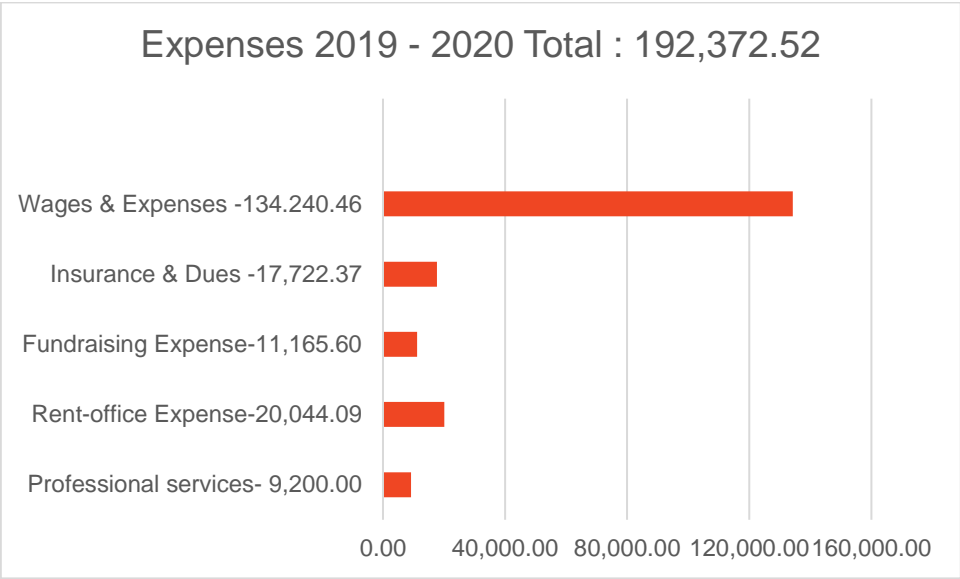
